

## BELLISIMO GRANITE WARRANTY

Bellisimo Granite is warranted to resist food and beverage stains under normal usage and care for a period of 15 years from the date of installation provided that the consumer is able to present a valid proof-of-purchase. Precision Countertops obligation will be limited solely to the cost of the repair or replacement of the actual countertop and will not include any additional costs such as labor; or incidental repairs or modifications. The repaired or replacement product is warranted for the remaining balance of the original warranty period.

During the warranty period, Authorized agents of Precision Countertops must be allowed sufficient time and opportunity to inspect the product to evaluate and respond to any claim. All decisions regarding the existence of defects or affecting this warranty shall be made by Precision Countertops and shall be final and binding. Should replacement of defective product be deemed the only plausible solution, every effort will be made for color match; however exact color match can not be guaranteed as stone is a product of nature and can be subject to both subtle and severe color variations.

## **EXCLUSIONS**

This warranty shall be null and void unless the product has been paid for in full. This warranty only covers food and beverage staining and does not apply to material subjected to damage due to:

- Mishandling
- Abnormal use
- Exposure to chemical abuse
- Exposure to direct or sustained hot or cold or sudden or rapid change in temperature resulting in thermal shock
- Force, pressure or loading applied from a person, utensil or object
- Commercial Installations
- Outdoor Installations

This warranty does not cover damage or effects caused by insufficient or poorly designed cabinets or supports.

This warranty does not cover any additional or supplemental repairs or modifications such as, any plumbing, electrical, tile or wall surface modifications that may be necessary to repair the Bellisimo product covered under this warranty; such repairs and modifications shall be the responsibility of the homeowner.

This warranty does not cover uses of products that have been exposed to acid etching, abnormal use, or conditions, or abuse in any way. "Abnormal use or conditions" include, but are not limited to, damage from mishandling or misuse, damage from excessive heat, scorching or uneven exposure to weather conditions, physical or chemical abuse damage from improper care and maintenance and damage from chipping, cracking, impact damage or breaking due to customer abuse. Precision Countertops is not responsible for damage or injury caused in whole or in part by acts of God, job site conditions, architectural and engineering design, structural movement, acts of vandalism, or accidents.

This warranty does not cover seam performance.
